- iv. Submission of enquiry report with specific findings and supporting documents along with the comments/recommendations within a reasonable period from the date of such receipt of a complaint.
 - v. Internal members of the committee are directed to hand over the charge & records to appropriate persons before relieving from the school while on transfer, leave or retirement and compliance report is to be submitted at the office.
- vi. Other provisions as per the Chapter-II, Section 4(3-5) of the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013.
